In pursuance to the Notification dated: 18.01.2016 cited at reference-1, recruitment process to fill up 18 posts of Police Sub-Inspector (Wireless) was initiated and after completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009, Provisional Select List cited at reference-2 was published on 29.06.2016.


2. Whereas, after publishing Provisional Select List for the above post, selected candidates were subjected to Medical Examination before duly constituted Medical Board. One candidate who was selected for the post viz., Sri Shreeshail Rabagond bearing Roll No. 9400330 was declared unfit by the Medical Board vide report cited at reference-3. Accordingly, the candidature of Sri Shreeshail Rabagond, was cancelled vide order No. 41/RECT-2/2015-16, Dated: 19.8.2016 cited at reference-4.
